Justification:

As part of the public contract, the contracting authority received one tender - the tender of the tenderer SOP Hilmbauer & Mauberger GmbH & Co KG, Siemensstrasse 5, 3300 Amstetten; FN 244905 f.

This tender was assessed by the evaluation committee and, on the basis of the documents submitted by the tenderer in its tender, the evaluation committee recommended the contracting authority to enter into a work contract with SOP Hilmbauer & Mauberger GmbH & Co KG.

The Supplier Selection Notice was sent on March 16, 2021 via the electronic tool E-ZAK. Together with the sending of the Decision on selection of the supplier, the contracting authority appealed the selected supplier SOP Hilmbauer & Mauberger GmbH & Co KG to provide cooperation before entering the contract – to send the current extract from the Commercial Register (or its Austrian counterpart, not older than 3 months before the tender date) and also on behalf of the selected supplier, a unilaterally signed contract for work, with the conditions and provisions of which the supplier agreed in the tender by signing a solemn declaration.

However, the selected supplier did not provide the necessary cooperation to the contracting authority - did not submit a unilaterally signed draft work contract, which was justified by the fact that the contract does not contain an agreement in case of exceeding the maximum number of mobilities, as well as supplier does not meet support times and impossibility to offer support in the Czech language as it was required by the contracting authority in business conditions with which, however, the selected supplier agreed and did not make any reservations about them at the tender submission stage.

Therefore, the contracting authority has no other option than to exclude the selected supplier from the tender by analogy with the provisions of Section 124, Paragraph 2 of the Act.
